NOTICE
(Fee Waiver Scheme)

In pursuance of the notification of Higher Education Department, Govt. of Assam, vide no. E-490303/2024/54, dated: 28-04-2025, it is hereby informed to all concerned that Fee Waiver Scheme shall be applicable to the following categories of students for admission into H.S. / Degree / M.A. / M.Sc. Courses under Higher Education Department, the scheme will continue for the year 2025-26, for those whose parental income is below 4.00 (Rupees Four Lakhs) per annum.

Applicability:


- Students whose parental annual income is less than 4.00 (Rupees Four Lakhs) per annum from all sources, will be eligible to avail this scheme.
- If either of the parent (father or mother) of the student is working in the State Govt. / Central Govt. / Semi Govt. / State or Central Govt. undertakings, such students shall not be eligible under this scheme.
- Scheme is only eligible for regular students having minimum 75 % of attendance in classes in previous year / semester with no back paper in previous examination, to be eligible for Fee Waiver claim in the subsequent year/semesters of study.

Proof of Income / Documents:

- An Income Certificate from the Local Revenue Circle Officer.
- Ration Card issued by the competent authority.
 - Either of the Income Certificate, so submitted by the candidate will be verified by the Competent Authority within one year and action as per Law will be taken against anyone where submission of false Certificate is established.
 - The College authority may grant admission to the students without examining the original mark sheet. However, the admitted students must produce their original mark sheet otherwise, the admission will be cancelled.
 - A declaration from the students that neither of the parents (father or mother) of the students is an employee of the State Govt., Central Govt. Department or its undertaking. If such a declaration is found to be false, the admission shall be cancelled and the admission fee shall be realized from such students.

Marking at the reverse of Marksheet of candidate given free admission:

- The College giving free admission under this scheme shall give one endorsement at the reverse of relevant mark sheet of the student, so that the student does not seek free admission in multiple colleges.
- The College shall devise Rubber Seal and use the seal at the reverse of Marksheets of beneficiary students.
